# Official contest rules and requirements

- A Specialty member is any member enrolled in Dental, Vision, Life, Supp Life, Short-Term Disability or Long-Term Disability.
- Travelers are taxed with a 1099 the year the trip is taken. The value of the trip is taxable to each of the winners in the year that the trip is taken. UnitedHealthcare will provide additional details upon request.
- Groups must be situated in California to qualify.
- Travel awards are limited to a maximum of 1 trip per agent and must meet the minimum member threshold total to qualify.
- Reporting will be tracked by each agency's sales lead and provided to UnitedHealthcare monthly during the contest period to validate and award contest winners. Final reporting will need to be provided to UnitedHealthcare on or before March 28, 2025.
- All travel must be booked 45 days in advance. Awards are based on availability at time of request. It is recommended to book early for your preferred travel dates.
- Winners will receive complete rules and instructions on how to book travel packages.
- Travel to be completed between June 1, 2025–June 30, 2026. Travel is excluded between Dec. 15, 2025–Jan. 7, 2026.
- Winners will be informed directly by their UnitedHealthcare account representative.

- Flight availability is based upon search criteria and flights that display at [ontheflyawards.com](https://ontheflyawards.com); On The Fly awards have a maximum redemption value, based on current airline pricing, not to exceed \$450
