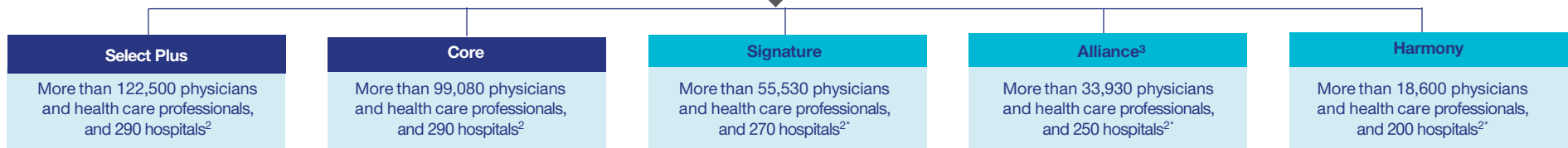


# Choice Simplified
