Placed Humana group dental coverage plus additional Group Benefits lines of coverage must have the same initial effective date of coverage. The enrolled dental subscriber count is used to determine minimum qualification but also the bonus amount.

All lines of coverage are subject to availability by case size and underwriting approval.
